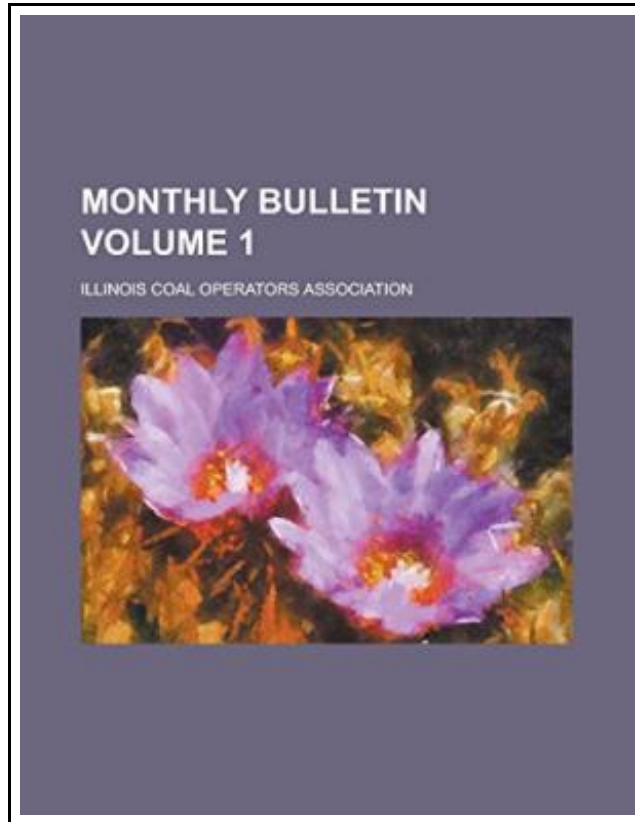

Board No. 1, met in Chicago, June 16th, and agreed as follows: It is agreed in the particular case at Toluca that it is optional with the miners whether or not to take the stump of coal outside of the break, and that they shall not be required to take it except under mutually satisfactory agreement with the Company as to compensation. If the stump is not so taken by the miners, the Company, at its option, may take it and possess the coal. Case No. 129. File No. 1512. (See Page 82, March 1909 Bulletin) Franklin County Investigating Committee. --This joint commission reported that they had been unable to reach any agreement. In the course of the discussion it was suggested that possibly some of the rules adopted with reference to the chain machine mines in Franklin County (See Case No. 10, Page 27, January, 1909, Bulletin) might also be applied to the other mines in Franklin County, and especially to the punch machine mines. The miners did not care to go into this phase of the question at that time, stating that some of the mines had not yet been visited. A motion was seconded and carried, providing that this joint commission be continued until some further meeting of the Joint Boards, and that in the meantime they arrange to investigate the conditions at all mines that had not heretofore been investigated and report to the Joint Board as soon as...
